New Business

- Doris Announcement of Anna Bognolo as new Director
- Doris reported that the Hiring Committee had 12 original interviews and invited four candidates for second interviews
- Doris we had voted in May to put bee sculpture out on a temporary basis for Bee Fest
- Doris turns meeting over to Rachael
- Rachael shared screen a flow diagram of the plaza/library facade that they had from building architects. Diagram has been labeled with numbers 1-4 by RK
- Rachael points out possible locations for bee sculpture to be installed locations are labeled as follows -
 - 1. Where sculpture was placed for Bee Fest. Rachel describes this as most free and clear from issues with flow
 - 2. Between the two trees. Rachael I like as well from an aesthetic point
 - 3. This location is closer to old building and corner of new driveway. RK says More risk with plow and vehicle traffic. Snow plow complications.
 - 4. Location is tucked against the building. Possible transient meeting place says RK
- Renderings (by RK) are shown with sculpture superimposed on flow chart to show clear positioning. RK says #2 spot is just as good as spot #1. #3 is more into traffic issues. #4 spot is not as visible, my 4th choice, but not a bad spot said RK
- Doris thanks Rachael for their great presentation
- Bill Benson asked about snow removal. RK they've talked with DPW all positions are fine, but #3 will be tricky. Bill asks where snow will be piled or pushed on plaza. RK did not discuss that detail with DPW.

- Sarah Ahearn Bellemare asked Who owns the bee? What is something were to happen to the bee? RK answered
 The bees have a big fan club in town. They are painted with automotive urethane. Not an issue with vandalism.
 Bees are very reinforced with 4 bolts on the pedestal. RK I'm backing these as long as I'm alive. Owned by the
 City of Greenfield.
